### DAY RELEASE CLASSES & GARDERIE FEES AND FINANCIAL ASSISTANCE 2024-2025

#### FEES

##### ✓ Deposits

- Requests for deposits are made once we are able to offer a place.
- Payment methods are the same as for fees (see below).
- For day release tuition, you will receive an invoice for one third of the fees for the first term of attendance. For the Garderie, termly fees will be payable at registration.
- The invoice is payable within 15 days to secure a place for your child.

Remission on Day Release Tuition Fees through the “[EFB Bursary Scheme 2024-2025](#)” if eligible.  
5% discount for families with 3 children registered at the EFB.

A prorated calculation of day release tuition fees will be made for an enrolment after the start of term if more than 2 days of tuition are missed. The charge will then be £42 per day for all the sessions remaining in the term.

- Fees include a nutritious mid-morning snack (and a wholesome mid-afternoon snack for children registered for evening Garderie).
- Parents provide a packed lunch.
- The EFB provides general school supplies.

Ad hoc Garderie bookings cost £9 per morning session, £12 per afternoon session.  
Invoicing will be separate.

### ✓ Invoicing and Payment Schedule

Day release tuition fees are invoiced in advance, in monthly instalments, on the first day of the month

The day release payment schedule is as follows\*:

\* We strongly encourage families to set up a standing order at registration

We will adjust schedules for new registrations part-way through a term.

Termly Garderie fees, for regular bookings are invoiced in advance.

The Garderie payment schedule is as follows:

Term 1	At registration date
Term 2	15/12/2024 for the 01/12/2024 invoice
Term 3	15/3/2025 for the 01/03/2025 invoice

We will adjust schedules for registration part-way through a term.

### ✓ Payment of fees

All fees can be paid by bank transfer.

Childcare **vouchers** can be accepted for day release or wraparound care fees.

**Payments from TAX FREE CHILDCARE ACCOUNTS can only be accepted for GARDERIE fees, NOT for day release tuition fees.**
