FEES

✓ Deposits

- The request for a deposit is made once we can offer a place.
- Payment methods are the same as for fees (see below).
- You will receive an invoice for one third of the fees for the first term of attendance. We will adjust the amount for arrival part-way through a term.
- The invoice is payable within 15 days to secure a place for your child.

✓ Fees, invoicing and payment terms

Annual registration fees

- New pupils: £50 per child
- Re-registered pupils: £25 per child

Daily fees are:

- £95.00 per day for full day care 8 am - 5.30 pm without a funded session – All inclusive.
- £37.00 per day for full day care 8 am - 5.30 pm with a funded session + wraparound care (Funded session £0 + French Programme Premium £18 + Wraparound care £19)
- £18.00 per day for a funded session from 9.00 am until 4.30 pm without wraparound care (Funded session £0 + French Programme Premium £18)

No charge is made for wraparound care on early closure days (2 per year).

We will provide an individual fee estimate at registration.

All fees are invoiced termly in three instalments, on the first day of the month, as per table below (We will adjust schedules for registration part-way through a term).

We strongly encourage families to set up a standing order at registration.

- Fees include nutritious mid-morning and mid-afternoon snacks.
- Parents provide a packed lunch.
- Parents supply nappies/wipes.
- All unfunded hours/wraparound care fees will be charged for the whole term (pro rata for a late start only).

Remission on fees through the French Government Scholarship Scheme if applicable. Conditions apply. 5% discount for families with 3 children registered at the EFB.

French Government Scheme

✓ **French government scholarship scheme**

Please consult the **official site** <https://uk.ambafrance.org/Bourses-scolaires-2025-2026> for detailed information about this scheme and access to application documents.

- Applications are through the Service Social of the French Consulate in London.
- Children must attend the French Maternelle Accredited Programme **4 days per week, Monday to Thursday** and they must be **French nationals** and be **registered with French Consulate in London**.
- Families’ maximum “patrimoine mobilier” €100,000, maximum “patrimoine immobilier » €300,000.
- Please check conditions relating to a *“recours gracieux”* if your child aged 3 at 31.12.2025 joins the EFB from January 2026 or later, rather than from September 2025.
- If your child is eligible to 4 funded sessions per week (30 hours), the award will only be calculated on the French Programme Premium. Please note that we provide the French Consulate with details of funded sessions that your child accessed, at the end of the school year; the award amount given in the initial letter is then revised downwards accordingly.
- The maximum fee basis for the calculation of the percentage remission is £10,536 per annum.
- The subsidy is not available on wraparound care fees, nor on the fees for a 5th day of attendance.

Please note that the outcome of summer applications will not be known before December 2025 or January 2026.

EFB Scheme

A credit for the French Programme Premium (Activity Fee) will be given to pupils eligible for the **Early Years Pupil Premium** once we receive confirmation of eligibility from Bristol City Council each term.

You must have filled in the relevant section of the EYR1 for us to be able to check eligibility with the Council.
